Show License Application[©] • General Instructions and Information

The SHOW secretary of the benching club should file the official show license application with CFA to be received in the Central Office with a postmark of at least 90 days prior to the opening day of the show. Applications received with a postmark of less than 90 days from the opening day of the show will incur late filing fees in addition to the regular show processing and show insurance fees as follows: 89-60 day postmark=\$50.00 fee; 59-30 day postmark=\$100.00 fee; 29 day postmark or less, but received not less than 7 days prior to the opening day of the show=\$500.00 fee. No show license will be granted for shows whose license is received in the Central Office with less than 7 days remaining prior to the opening day of the show. The appropriate fees must accompany the application: the show processing fee (\$100.00), the show insurance fee (\$100.00), yearly club fees (\$120.00 effective 1/1/2011 and \$145 effective 1/1/2012) for the benching club and, if applicable, any ring sponsors, and any late filing fees, if appropriate. **Yearly club fees must be paid for all interim years up to and including the year in which the show is scheduled to be held.**

A club invited to sponsor an allbreed or specialty ring in another club's show must provide a completed license application and send ALL three copies to the show secretary of the club benching the show. NOTE – if the club is sponsoring more than one ring, only ONE completed application need be submitted for those rings.

Clubs are permitted to schedule one ring for which no judge(s) has been contracted. This type of situation is commonly referred to as a "to be announced" (TBA) ring. If a club chooses to schedule such a ring, insert the type of ring being scheduled and enter the initials "TBA" in the judge's name section. A completed judge's contract (to include the name and signature of the judge) for any previously scheduled TBA judge(s) should be received in the Central Office no later than 90 days prior to the opening day of the show.

Type of Show	List show format, e.g. 4AB, 2Spec, 1JS; 8 Spec; 5AB/1Spec Champ. & Kits, 6AB Premiership
Entry Limit	If known, list maximum number of entries permitted at the show, e.g. 225, 350, 450.
Date(s) of Show	If entries are not required to be present for both days of a two day show, please indicate as follows: Saturday LH, Sunday SH.
Show Secretary	Information requested, which includes street address and daytime telephone, will be used by Central Office ONLY.
Entry Clerk	List only the information to be included for publication.

FEES TO BE PAID

- Yearly club fees for ALL participating clubs up to and including the year of the show date – \$120 or \$145 (see above)
- Show Insurance Premium – \$100.00 per show.
- Show Processing Fee – \$100.00 per show.

FORMS TO BE SUBMITTED

- Application(s) for each participating club completed as necessary.
- Completed and signed contracts for every judge.
- Two copies (white and yellow) of the show license application.
